BY-LAW 01-2023

BY-LAW NO. 01-2023 AMENDING BY-LAW NO. 911-2016 ORDERING THE IMPOSITION OF A TAX
FOR THE PURPOSE OF FUNDING 9-1-1 EMERGENCY CENTRES.

THE COUNCIL DECREES AS FOLLOWS.

1. SECTION 2 OF BY-LAW NUMBER 911-2016 IS REPLACED BY THE FOLLOWING:

FROM 1 JANUARY 2024 IS TAXED ON THE SUPPLY OF A SERVICE
TELEPHONE A TAX THE AMOUNT OF WHICH IS, FOR EACH SERVICE
TELEPHONE, \$0.52 PER MONTH PER TELEPHONE NUMBER OR, IN THE CASE OF
FROM A MULTI-LINE SERVICE OTHER THAN A CENTREX SERVICE, PER ACCESS LINE OF
DEPARTURE.

2. REGULATION NUMBER 911-2016 IS AMENDED BY ADDING THE FOLLOWING AFTER SECTION 1:

THE AMOUNT OF THE TAX IS INDEXED ON 1 JANUARY OF EACH YEAR
STARTING IN 2025, AT THE RATE CORRESPONDING TO THE ANNUAL CHANGE IN
THE ALL-ITEMS AVERAGE CONSUMER PRICE INDEX FOR QUEBEC,
EXCLUDING ALCOHOLIC BEVERAGES, TOBACCO PRODUCTS, ARTICLES FOR
SMOKERS AND RECREATIONAL CANNABIS, FOR THE 12-MONTH PERIOD ENDING
JUNE 30 OF THE YEAR PRECEDING THAT FOR WHICH THE AMOUNT OF THE TAX
MUST BE INDEXED.
THIS AMOUNT, THUS INDEXED, IS REDUCED. TO THE NEAREST CENT IF IT INCLUDES
A FRACTION OF A CENT LESS THAN \$0.005; IT IS INCREASED TO THE NEAREST CENT
CLOSE IF IT INCLUDES A FRACTION OF A CENT EQUAL TO OR GREATER THAN \$0.005.
THE RESULT OF THIS INDEXATION CORRESPONDS TO THE AMOUNT PUBLISHED BY THE MINISTER
MUNICIPAL AFFAIRS, REGIONS AND LAND OCCUPANCY IN
PART 1 OF THE GAZETTE OFFICIELLE DU QUÉBEC, IN ACCORDANCE WITH SECTION 2.1
THE BY-LAW GOVERNING THE MUNICIPAL TAX FOR 9-1-1 (CHAPTER F-2.1, R.14)

3 THESE REGULATIONS COME INTO FORCE ON THE DAY ON WHICH A NOTICE IS PUBLISHED
TO THAT END, THE MINISTER OF MUNICIPAL AFFAIRS, REGIONS AND THE OCCUPATION OF
THE TERRITORY SHALL BE PUBLISHED IN THE GAZETTE OFFICIELLE DU QUÉBEC
