B. By-Law 2025-003 Speed Limits

124-2025 BYLAW NUMBER 2025-003

BY-LAW RESPECTING SPEED LIMITS ON TRIPP ROAD AND FORT-WILLIAM ROAD IN THE MUNICIPALITY OF SHEENBORO

WHEREAS subparagraph 4 of the first paragraph of section 626 of the Highway Safety Code (R.S.Q., c. C-24.2) allows a municipality to set by-law the minimum or maximum speed of road vehicles within its territory.
WHEREAS notice of motion for this by-law was given at a meeting of the Municipal Council of the Municipality of Sheenboro held on June 2, 2025

WHEREAS the first draft by-law was adopted at a meeting of the Municipal Council of the Municipality of Sheenboro on June 2, 2025 and entered in the minutes book under number

THEREFORE, it is moved by Councillor Bradshaw that By-law No. 2025-003 be adopted and that, consequently, the Council enacts:

ARTICLE 1

This by-law is entitled: "2025-003 By-law Concerning Speed Limits on Tripp Road and Fort-William road in the Municipality of Sheenboro"

ARTICLE 2

No person may drive a road vehicle at a speed:

- a) Exceeding 50 km/h on Tripp Road

ARTICLE 3

Appropriate signage shall be installed by The Municipality of Sheenboro Roads Team

ARTICLE 4

Anyone who violates Section 2 of this by-law commits an offense and is liable to a fine as provided for in Section 516 or 516.1 of the Highway Safety Code.

ARTICLE 5

This by-law will come into force on the date of its publication, scheduled for July 8, 2025.
